"A Different Story to Tell"

After graduating from high school, Edwin Salgado and his family began looking for services to continue his development, and we

are so glad he chose Goodwill. In the beginning of his participation in day services, Edwin would isolate himself and engage in only one activity-watching videos on his iPad. He was not interested in spending time with his peers or going on community outings, and due to Edwin's lack of acknowledgement of others, his peers would walk away when he would talk to them. He communicated aggressively, often hitting himself and being confrontational with others. After spending time in services, now there is a different story to tell. Edwin regularly goes on community outings - his favorite is Pete's Safari. He also initiates interactions with others, is willing to engage in various activities, and has established a routine that sets him up for success each day.



### Trusting the Process"

A conviction of possession of a controlled substance, addiction, a struggle with mental and physical health,

unhealthy relationships, homelessness, and unemployment are significant barriers to overcome. Initially, Heidi Louthan wasn't all that interested in making any changes. But to get her conviction expunded, Heidi was required to successfully complete Drug Court (A very demanding 18 month program). She was non-compliant and worked hard to avoid participating in Goodwill services, adding to her struggles. Over time, Heidi decided to "trust the process," and accepted help. Trusting the process is now Heidi's motto. She graduated from Drug Court in February 2023, is making improvements to stabilize her physical and mental health, lives in her own apartment, and frequently works overtime. Heidi's willingness to be vulnerable, accept help, and using her strength to overcome challenges is an inspiration.

Goodwill employees work with individuals to help them build skills, become competitively employed, and maintain employment in the community. We also work with employers to ensure a match between gualified candidates and job openings, maintain a strong, responsive working relationship with employers to address ongoing needs. Our services help individuals living with a behavioral health diagnosis and/or substance use disorder, intellectual or developmental disability, acquired brain injury, autism spectrum disorder, or other barriers to employment to develop skills to successfully obtain and maintain employment.

Jacob Burt was struggling to find a job and was feeling depressed and overwhelmed. He learned about our employment

services while at a probation class and after giving it some thought, Jacob decided to give Goodwill a try. Jacob and his employment specialist got to work exploring available jobs, creating a resume, and submitting applications. Jacob's diligence paid off – he is now working full-time as a HVAC Technician. Jacob's boss gives great reviews about his work, shares that Jacob will complete any assigned task and doesn't let his disability (Jacob is Legally Blind) stand in his way. He is learning new skills and is positive, driven and thankful



"Hurdles to Overcome"

Prison, transitional shelter living, substance use disorder, mental health concerns, unemployment, and no healthy support system are some hefty

hurdles to overcome. Michael Powers had goals for himself, he just was not quite sure how to reach them. Working diligently with Goodwill behavioral health staff, his situation started to change. He acquired important life skills – setting healthy boundaries, the importance of healthy relationships, budgeting, independent living and healthy coping skills. He also received employment services. Mike successfully completed probation, is working, has his own apartment, and recently paid off his last debt. He is working on getting his driver's license. Mike has worked hard and has cultivated the stability he desires.



# "Confident & Healthy"

A car accident that nearly cost Jacky Costello (Jacquelynne) her life resulted in having to regain the ability to walk and talk. As she had little support from others Jacky struggled doing everyday activities, lacked confidence, and was hesitant to participate in any social situation. Jacky was working but needed support to maintain employment. Jacky's employment specialist worked with both Jacky and the employer to find solutions. Not only has Jacky maintained employment at The Lodge for a year, she is now working more hours per week. Jacky's quality of life has improved, she is confident, and both physically and mentally healthy.


