






Developmental Disability Services

Goodwill Industries of Greater Nebraska provides Developmental Disability Services designed to help individuals with intellectual or developmental disabilities acquire, improve, and retain essential life skills. These services promote independence, empower individuals to make choices, and encourage active participation in their communities.

Delivered across locations in Grand Island, Hastings, and Kearney, the programs offer personalized supports that leverage each person's strengths and talents. Whether through day support services, community integration services, or shared living arrangements, Goodwill's approach fosters dignity, inclusion, and personal growth.

Behavioral Health Services

Goodwill's Behavioral Health Services focus on recovery, wellness, and community integration for individuals living with mental health conditions or substance use disorders. Provided in Grand Island and Columbus, these services include community support, emergency community support, day services, and resource acquisition assistance.

Individuals receive holistic care that addresses both clinical and social needs, with an emphasis on building resilience, fostering healthy relationships, and achieving personal goals. Goodwill's behavioral health team works in partnership with regional health systems and community organizations to ensure accessible, compassionate, and effective support.

Employment & Career Services

The Employment and Career Services program supports individuals facing barriers, disabilities, or poverty through employment services and benefits counseling supports.

Operating in communities including Columbus, Grand Island, Kearney, Hastings, Lexington, Lincoln, North Platte, and McCook, Goodwill staff work closely with individuals to identify career goals, build resumes, develop workplace skills, and secure and maintain employment. Through certified benefits counseling, individuals are provided assistance in understanding their disability related benefits and accessing work incentives to help them earn more and achieve career goals.

The program emphasizes empowerment through employment, helping individuals achieve financial independence and long-term stability.

Barb Engberg, an owner of Live Well Physical Therapy, has been an active member of the Goodwill Operating Board since 2020. During her time on the board, Barb has served on the Finance/Retail and HR/Mission Services/Housing Committees, chairing the latter, and as a member of the Executive Committee. Barb has provided unwavering support for our Goodwill through her board involvement and commitment to supporting meaningful employment opportunities for people living with a disability. Her drive to support a diverse and inclusive workforce makes her an ideal partner and a tremendous asset to our community.

Mitchell Thompson of Live Well joined our board in 2024 and serves on the HR/Mission Services/Housing Committee. Although Mitchell's involvement with Goodwill has just begun, we look forward to his contributions and achievements. In addition to the service provided by Live Well on the operating board, they also employ individuals through the employment and career services program. Jae and Serena, individuals in services, are working at Livewell as part of the Developmental Disabilities Supported Employment Program.

Serena worked with Jen Barker on her employment goal to find a job folding laundry. Knowing Barb through the Goodwill Board, Jen recognized that a physical therapy office would have daily laundry needs. Together, Jen and Barb developed a customized job that includes tasks such as cleaning and folding laundry used in the practice. Serena and Jae were hired to fulfill these needs collectively, with Jae working two days a week and Serena working three days a week. Barb has worked closely with both of them and Jen to ensure that they receive ample support.

Live Well Physical Therapy has proved to be an excellent employer, demonstrating a willingness to work with and support its employees. For 2024-2025, we were pleased to present the Distinguished Community Partner Award to LiveWell Physical Therapy.

Disability Pride Day

Goodwill's first Disability Pride Celebration united people with disabilities, families, staff, and community partners for a day of recognition and joy. Inspired by the Americans with Disabilities Act (ADA), the event included awards, games, and lunch, celebrating milestones and volunteerism. The success of this event has established Disability Pride as a must-have annual tradition, amplifying Goodwill's commitment to building a more inclusive and supportive environment for all.





In 2025, Goodwill projects were funded .06% or \$13,521 by the Block Grants for Community Mental Health Services, CFDA Number 93.958, contracted through the Department of Health and Human Services, Division of Behavioral Health, Additionally, 27.87% or \$5.818.650 of Medicaid HCBS Developmental Disabilities Waiver, 6.6% or \$1,378,576 of Department of Health and Human Services, Division of Behavioral Health, 5.46% or \$1,140,238 of Nebraska VR, 2.75% or \$574,979 of Medicaid, .52% or \$109,139 of Social Security Administration, 1.02% or \$213,152 of US Department of Housing and Urban Development, .35% or \$72,536 of grant, .20% or \$41,442 of Child and Adult Care Food Program, and 53.32% or \$11,130,355 of non-governmental or self-funding is supporting the projects.
