Lincoln, NE— In April 2024, Governor Jim Pillen signed the Individuals with Intellectual and Developmental Disabilities into law, effective Ja.

Employers:

\$500 per direct support professional (DSP) employed ≥ 6 months, S00 hours or more

Direct support professionals: \$500 if employed as a DSP ≥ 6 months, GCO hours or more

Employers (HCBS):

\$1,000 per employee receiving Medicaid Home and Community-Based Services (HCBS) employed ≥ 6 months, 200 hours or more

Tax credit allo locations:

- Up to \$1,000,000 for fiscal year 2025-2026
- \$1,500,000 for fiscar 2026-2027
- \$2000,000 annually thereafter
