Advocacy Efforts

The following is a brief summary of several bills that have recently been introduced in the Nebraska Legislature concerning Medicaid, disabilities, and behavioral health. While these legislative proposals may not directly impact Goodwill services at this time, it is important to remain informed as developments may occur. Advocacy involves staying aware of policy changes and voicing concerns when necessary to ensure your perspectives are considered. Goodwill is committed to keeping updated on these issues and will share information about changes as available.

Resource Roundup

Public Comment Period - January 26 through February 25, 2026

Pursuant to 42 C.F.R. §441.304(f), the Nebraska Department of Health and Human Services (DHHS) is required to give public notice related to the state's plan to amend the 1915(c) Medicaid Home and Community Based Services (HCBS) Comprehensive Developmental Disabilities Services (NE.4154) waiver and the Developmental Disabilities Day Services Waiver for Adults (NE.0394). The 30-day public comment period will be from January 26 to February 25, 2026.

Upon approval by the Centers for Medicare and Medicaid Services (CMS), these waiver amendments would go into effect July 1, 2026.

The Public Comment page also has information about the plan to renew the Aged and Adult and Children with Disabilities Waiver (NE.0187) and amend the Traumatic Brain Injury Waiver (NE.40199). The 30-day public comment period was from December 5, 2025, through January 5, 2026.
